It is that time of year again, so mark your calendars! **Open Enrollment** will be conducted **November 7**th - **November 18**th online via **Greenshades**. In 2023, we will continue to offer a Minimum Essential Coverage (MEC) Plan.

What is a Minimum Essential Coverage (MEC) Plan?

This is a type of medical plan offered at an affordable cost that you pay through payroll deductions. It includes minimum essential coverage (MEC), meaning they give you 100% coverage for preventative services required by law, have no annual fee or lifetime dollar amounts, and no pre-existing condition exclusions or limitations. In addition, it also helps you pay for a range of covered health care services.

For certain covered services, the plans will pay for a specific number of health care visits each year. You will only have a copay for each visit. Once you pay the specific copay for these services, you will not have to pay anything else. For other services, the plans will pay up to a maximum amount each year to help with costs. Please refer to your open enrollment materials for plan details.

How Do I Enroll?

Your Enrollment is completed online through Greenshades. You can login to Greenshades in one of two ways:

*** You must complete the entire enrollment process and submit the election changes by November 18th for them to take effect on January 1, 2023 ***

NOTE: Once Open Enrollment is closed, your next opportunity to enroll or make changes is during our next annual open enrollment or if you experience a qualifying life event. You will be responsible for weekly payroll deductions and any missed deductions will automatically be scheduled for payment.
